
TRUTH IN TAXATION CERTIFICATION OF COMPLIANCE



An ordinance levying taxes for all road purposes for New Lenox Township Road District, Will County, Illinois, for the tax year 2019, collectable in 2020.

BE IT ORDAINED by the Board of Trustees of New Lenox Township, Will County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of New Lenox Township Road District on December 12th, 2019 does hereby determine and declare that the sum of Two Million Eight Hundred Ten Thousand Eight Hundred and Seventy Six dollars.(\$2,810,876.00.) are hereby levied for the year 2019. upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- ROAD & BRIDGE FUND**
- BUILDING & EQUIPMENT FUND**
- INSURANCE FUND**

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for New Lenox Township Road District.




SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
